Notice of Arrangements for Public Participation on the Consultation of Draft Supplementary Planning Document

Cambridge City Council has prepared a draft Land North of Cherry Hinton Development Framework Supplementary Planning Document (SPD). The site is located between Airport Way and Cambridge Airport, north of Coldham's Lane and comprises 47 hectares in area.

The Development Framework is being prepared as an SPD in order to help guide the preparation and assessment of future planning applications and re-development within the Area. It will also support allocation R47 Land North of Cherry Hinton identified within Policy 12: Cambridge East and Appendix B of the Cambridge Local Plan 2014: Proposed Submission (as amended) and Policy SS/3 (Cambridge East) of the South Cambridgeshire Proposed Submission Plan 2014 (as amended).

An eight-week consultation period on the draft Development Framework will run from:

9am on 7 August 2017 to 5pm on 2 October 2017
