Cambridge City Council has prepared a Draft Planning and Development Brief Supplementary Planning Document (SPD) for the Mill Road Depot site on Mill Road.

The SPD will help guide the re-development of the site for housing and will provide detail to support the site's delivery. It outlines the aspirations of the site, as well as the key issues, constraints and opportunities that will influence how future development on the site will take place. The draft SPD has been prepared to support the delivery of the entire site which is allocated as Site R10 in the emerging Cambridge Local Plan 2014: Proposed Submission (as amended).
