Yes, a positive impact

The SPD will encourage the enhancement of the public realm within the Mitcham's Corner Opportunity Area and improve pedestrian movement throughout the area.

Public realm improvements and enhancements will provide new places for people of all ages to relax and enjoy, which are closer to their place of residence.

Improvements to pedestrian and cycle movement within the area will improve safety and restore the balance between people and motor vehicles. This would make the Mitcham's Corner Junction less fragmented and allow easier access to all areas and key services (such as dentists, local shops etc.) within the opportunity area.

The creation of a low speed environment and the possiblility of reconnecting existing communities currently severed by the existing road network will enable the greater interaction between businesses and residents of all ages.

The potential for improved bus services within the area will also enable those who lack personal transport to travel freely across Cambridge.

(b) Disability (including people with a physical impairment, sensory impairment, learning disability, mental health problem or other condition which has an impact on their daily life)

Yes, a positive impact

Once introduced the document will help ensure new development within the Mitcham's Corner Opportunity Area provides improved access for people with limited mobility, through improvments to the public realm, access to public transport and a safer environment with regards to transit to and through the area. The Local Plan also includes policies to improve accessibility.

(c) Gender

Cambridge City Councils Access Officer was consulted on 17 August 2016, their conclusion is as follows:

The draft Mitcham's Corner Development Framework SPD will, in the long term, have a positive effect on disabled people. This positive effect will be produced by improvements to the public realm within the Mitcham's Corner area and the potential for improved junctions and road crossings making travel across the area safer and less complicated.

In the short term, people with visual impairments may be impacted upon whilst improvements to the public realm are undertaken. Impacts could include the positioning of building equipment and items left on the pavements during the construction stage and the adaption needed to navigate a new road layout once improvements are completed. These issues however, will be discussed and dealt with at the planning application stage in consultation with the Disability Consultative Panel in order to minimise the impact on the visually impaired.
